Based on the LoI, IEA, Statement of Compliance, Self Study Report submitted by the University, Peer Review Team recommendations and report of Review committee constituted to examine Action Taken Report submitted by the University, the National Agricultural Education Accreditation Board of ICAR in its XXVIII meeting held on August 17, 2021, approved accreditation of Rani Lakshmi Bai Central Agricultural University, Jhansi for a period of five years i.e. from 17.08.2021 to 16.08.2026 with overall Score of 2.51 equivalent to Grade 'C'.

The details of accredited programme & college of the University along with remarks made by the Board are enclosed herewith as Annexure-I and Annexure-II respectively. Accreditation to the university has been granted with the following conditions:-

1. The University is required to address the observations of the Board in a time bound manner. As per the Board decision, a Mid-term review will be conducted.
2. Board further decided that student intake in the programme and strength of faculty/technical/supporting staff as listed in Self Study Reports and undertaking given by the registrar during Peer Review, if any, must be maintained by the university/College/Programme throughout the accreditation period.
3. University should annually upload intake of students in all accredited programmes and College /programmes faculty positions on its website and convey the copy of same to NAEAB before starting of admissions.

Subject: Appeal filed by the College of Horticulture and Forestry and its programmes viz. B.Sc (Hons.) Forestry and B.Sc. (Hons.) Horticulture against decision of the Board-regarding

Sir,

Based on the request submitted by the university vide 93/RLBCAU(VI)/2021 dated 11.10.2021, the Appeal Committee of the NAEAB held its meeting on 23.11.2021 regarding reassessment and examination of PRT report, Self Study Report and ATRs. The College of Horticulture and Forestry and its programmes viz. B.Sc (Hons.) Forestry and B.Sc. (Hons.) Horticulture has been recommended for accreditation *subject to fulfilling the following conditions:*

- In view of involvement of 24 scientists of IGFRI and CAFRI in teaching program, a separate MoU should be developed between the RLBCU and two institute of ICAR viz. IGFRI and CAFRI with the commitment from the ICAR Institutes to identify pertinent scientists for teaching undergraduate courses of B.Sc (Hons) Forestry and B.Sc (Hons) Horticulture as per course curricula of V<sup>th</sup> Deans Committee. All the scientists covered under MoU should also be given due recognition such making them as course leader etc. in their respective specialization. A copy of the above MoU should be submitted to the NAEAB for its consideration and final decision on accreditation board during its next meeting.
- The university should get required faculty strength sanctioned (as per Vth Deans' Committee Report within one year period and submit report to the Board for reviewing continuation of the further accreditation.

Therefore you are kindly requested to send a copy of MoU as stated above and necessary action may be taken for above observations immediatel.
